RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY

The 2003 Security Agreement was also duly recorded on February 9, 2004, at Patent Reel/Frame 014964/0728 in the United States Patent and Trademark Office, and pursuant to which the Grantor assigned and granted to Bank a security interest in and to all of Grantor's right, title and interest in and to its patents, patent applications, and other intellectual property, including certain patents and/or patent applications listed on Exhibit B attached hereto.

The 2007 Security Agreement was duly recorded on June 5, 2007, at Trademark Reel/Frame 003557/0930 in the United States Patent and Trademark Office, and pursuant to which the Grantor assigned and granted to Bank a security interest in and to all of Grantor's right, title and interest in and to its trademarks, trademark applications, and other intellectual property, including certain trademarks and/or trademark applications listed on Exhibit A attached hereto, and the goodwill associated therewith.

The 2007 Security Agreement was also duly recorded on June 5, 2007, at Patent Reel/Frame 019406/0724 in the United States Patent and Trademark Office, and pursuant to which the Grantor assigned and granted to Bank a security interest in and to all of Grantor's right, title and interest in and to its patents, patent applications, and other intellectual property, including certain patents and/or patent applications listed on Exhibit B attached hereto.

The trademarks and trademark applications listed on Exhibit A attached hereto are the "Released Marks", and the patents and patent applications listed on Exhibit B attached hereto are the "Released Patents".

Bank wishes to release and retransfer to Grantor, without representation or warranty, all of Agent's right, title and interest in and to the Released Marks, and the goodwill associated therewith, and the Released Patents.

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Bank, its successors, legal representatives and assigns, hereby releases and

discharges fully its security interest in and to the Released Marks and the Released Patents, and retransfers to Grantor, without representation or warranty of any kind, express or implied, free and clear of any claims by Bank, all of Bank's right, title and interest in and to the Released Marks, the goodwill associated therewith, the Released Patents, and all causes of action for past infringement, if any.


