AFFIDAVIT OF PATRICK J. GALLAGHER


I, PATRICK J. GALLAGHER, of St. Paul, Minnesota, United States of America, MAKE OATH AND SAY AS FOLLOWS:

1. I am Patrick J. Gallagher, Partner at Fulbright & Jaworski L.L.P. and correspondent of record for the Recorded Assignment Document for which a Corrective Assignment is being submitted. I therefore have personal knowledge of the matter for which I hereinafter depose. I am also duly authorized to make this affidavit on behalf of the Owner, SunPower Corporation.
2. SunPower Corporation has been incorporated under the laws of the State of Delaware since May 25, 2004, in the United States of America and has its head office located at 77 Rio Robles, San Jose, California 95134 (formerly 3939 N. 1st Street, San Jose, California 95134). SunPower Corporation (a Delaware corporation) is the successor corporation of SunPower Corporation (a California corporation), which was incorporated in 1985 and, as a result of several subsequent corporate changes, now operates as SunPower Corporation (a Delaware corporation).
3. SunPower Corporation (a Delaware corporation) inadvertently recorded a Trademark Assignment with the Assignment Branch of the U.S. Patent and Trademark Office that contained a typo listing the entity as a "California" corporation rather than a "Delaware" corporation. No California entity existed at the time the Trademark Assignment was executed, nor when the document was submitted for recordation (nor since that time) for SunPower Corporation a "California" corporation.

4. This affidavit is being submitted in conjunction with a corrective assignment recordation request concerning the document previously recorded on September 18, 2009, at Reel/Frame 4064/0516. In the Corrective Assignment, we are requesting that the record be corrected to reflect the correct entity as Owner, namely, SunPower Corporation, a Delaware corporation -- not a California corporation.

I, the undersigned, being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. §1001, and that such willful false statements may jeopardize the validity of this document, declare that I am properly authorized to execute this document on behalf of the Owner, and all statements made of my own knowledge are true and that all statements made on information and belief are believed to be true.
