Release of Trademark Collateral Assignment and Security Agreement

This Release of Trademark Collateral Assignment and Security Agreement ("Agreement") is made as of the 27th day of June, 2012 ("Effective Date"), between vonGal Corporation, a Delaware corporation with its chief executive office and place of business at 3101 Heyneville Road, Montgomery, Alabama 36108 ("Assignor") and Enterprise Bank & Trust, a banking institution organized under the laws of the state of Missouri with an office at 150 North Meramec, Clayton, Missouri 63105 ("Enterprise").

WITNESSETH:

WHEREAS, Assignor executed and delivered a Revolving Credit Note to Enterprise in the aggregate principal amount of \$1,500,000, pursuant to a certain Credit Agreement dated as of December 12, 2011, between Assignor and Enterprise (together with all schedules and exhibits thereto and as amended from time to time, the "Credit Agreement"); and

WHEREAS, in order to induce Enterprise to execute and deliver the Credit Agreement, Assignor granted to Enterprise pursuant to that certain Trademark Collateral Assignment and Security Agreement dated December 12, 2011 (the "Trademark Collateral Assignment and Security Agreement") a security interest in certain Trademarks (as defined in the Trademark Collateral Assignment and Security Agreement and identified in Schedule A hereto) owned by Assignor; and

WHEREAS, Assignor has requested that Enterprise release its security interests in the Trademarks and Enterprise has agreed to such release.

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby agrees with Enterprise as follows:

Enterprise hereby releases its security interest in and to, and reassigns, grants and conveys to Assignor, without any representation, warranty, recourse or undertaking by Enterprise, all of its right, title and interest, if any, in and to the Trademarks.

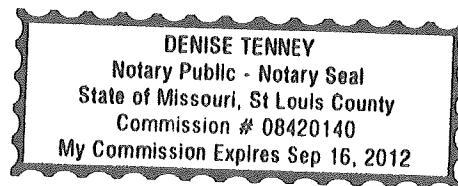
