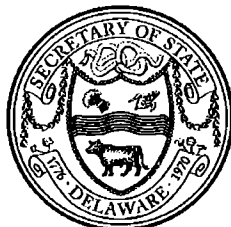

CERTIFICATE OF MERGER
OF
HIGH PRESSURE EQUIPMENT COMPANY
INTO
HIP ACQUISITION LLC

Pursuant to Section 18-209 of the Limited Liability Company Act of the State of Delaware and
Section 1926 of the Business Corporation Law of the Commonwealth of Pennsylvania

FIRST: The name and jurisdiction of formation or organization and domicile of each of the constituent entities is: HiP Acquisition LLC, a Delaware limited liability company (the "LLC") and High Pressure Equipment Company, a Pennsylvania corporation (the "Corporation").

SECOND: The LLC and the Corporation have entered into an Agreement and Plan of Merger, dated as of June 29, 2012 (the "Merger Agreement"), providing for the merger of the Corporation with and into the LLC (the "Merger") pursuant to Section 18-209 of the Limited Liability Company Act of the State of Delaware (the "DLLCA") and Section 1926 of the Business Corporation Law of the Commonwealth of Pennsylvania (the "PBCL"). The Merger Agreement has been approved and executed in accordance with Sections 204 and 209 of the DLLCA, in the case of the LLC, and 1924 and 1926 of the PBCL, in the case of the Corporation.

THIRD: HiP Acquisition LLC shall be the surviving limited liability company in the merger (the "Surviving LLC").

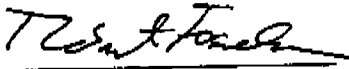
FOURTH: The name of the Surviving LLC shall be changed to High Pressure Equipment Company LLC pursuant to the Merger and the Certificate of Formation of the Surviving LLC shall be amended to reflect this change so that Section 1 thereof reads in its entirety as set forth below:

1. The name of the limited liability company is High Pressure Equipment Company LLC.

FIFTH: The Merger Agreement is on file at an office of the Surviving LLC at High Pressure Equipment Company LLC, c/o Wasserstein & Co., L.P., 1301 Avenue of the Americas, 41st floor, New York New York, 10019. A copy of the Merger Agreement will be furnished by the Surviving LLC, on request and without cost, to any member of the LLC or to any stockholder of the Corporation.

IN WITNESS WHEREOF, HiP Acquisition LLC has caused this Certificate of Merger to be duly executed on this 29th day of June, 2012.
