ARTICLES OF AMENDMENT NO. 2
OF THE
ARTICLES OF INCORPORATION
OF

(Pursuant to Section 302A.139 of the Minnesota Business Corporation Act)

Cross Telecom Corporation (the "*Corporation*"), a corporation duly organized and existing under the Minnesota Business Corporation Act, as amended, does hereby certify that:

2. The Corporation's current Articles of Incorporation are hereby amended to change the name of the Corporation by deleting ARTICLE 1 in its entirety and substituting the following in lieu thereof:

"ARTICLE 1. NAME
