THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of July 2, 2012, and made by JPMorgan Chase Bank, N.A., having an office at 2200 Ross Avenue, 3<sup>rd</sup> Floor, TX1-2903, Dallas, Texas 75201 ("JPMorgan") to P.F. Chang's China Bistro, Inc. (the "Grantor").
