IN TRADEMARKS**

THIS TERMINATION OF SECURITY INTEREST IN TRADEMARKS (this "Termination"), dated as of July 2, 2012, is executed by SILICON VALLEY BANK, with its principal place of business located at 2400 Hanover Street, Palo Alto, California, 94304, as Secured Party (together with its successors and assigns, "Secured Party"), in favor of invivodata, Inc., a Delaware corporation (together with its successors and assigns, "Debtor").
