**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of July 3, 2012, is made by WF FUND III LIMITED PARTNERSHIP, carrying on business as WELLINGTON FINANCIAL LP and WELLINGTON FINANCIAL FUND III ("**Lender**"), as a lender under that certain Loan and Security Agreement, dated as of December 30, 2009, by and between Ember Corporation ("**Borrower**") and Lender (the "**Loan and Security Agreement**"), Borrower and Lender entered into that certain Patent Security Agreement, dated as of December 30, 2009 (the "**Patent Security Agreement**"), by and between Borrower and Lender, and that certain Trademark Security Agreement, dated as of December 30, 2009 (the "**Trademark Security Agreement**"), by and between Borrower and Lender (The Loan and Security Agreement, Trademark Security Agreement and Patent Security Agreement collectively, the "**Security Agreements**"). Terms used in this Release and not herein defined shall have the meanings set forth in the Security Agreements, as applicable.

WHEREAS, in connection with the Loan and Security Agreement, the Borrower granted a Lien on and security interest in the Collateral to the Lender for the benefit of Lender;

WHEREAS, pursuant to the Loan and Security Agreement, Borrower entered into the Patent Security Agreement and the Trademark Security Agreement, and granted security interests in certain intellectual property owned by Borrower, including those listed on Annex I attached hereto (collectively, the "**Intellectual Property Collateral**"); and

WHEREAS, the Security Agreements were recorded in the U.S. Patent and Trademark Office and/or the U.S. Copyright Office, as applicable, on the dates and on the reels and frames set forth on Annex I hereto;


NOW THEREFORE, Lender hereby releases, without representation, recourse or warranty whatsoever, all of its security interests in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with each Security Agreement, and Lender hereby reassigns any and all such right, title and interest (if any) that Lender may have in the Intellectual Property Collateral to the Borrower.

Lender agrees, at the expense of the Borrower, to cooperate with the Borrower and to provide the Borrower with the information and additional authorization reasonably required to effect the release of Lender's security interests in the Intellectual Property Collateral.
