TRADEMARK RELEASE

TRADEMARK RELEASE, effective as of this 3rd day of July, 2012, given by Deutsche Bank Trust Company Americas, as Collateral Agent ("Agent") with principal offices at 60 Wall Street, New York, NY 10005, to Consolidated Container Company LP, a Delaware limited partnership ("Grantor"), with principal offices at 3101 Towercreek Parkway, Suite 300, Atlanta, GA 30339, as follows:

WHEREAS, the Grantor has heretofore granted to the Agent a security interest in certain U.S. trademarks, trademark registrations and trademark applications more particularly set forth on Schedule A attached hereto (the "Marks") to secure the Obligations (as defined in that certain First-Lien Security Agreement, dated as of March 28, 2007, between the Agent and the Grantor (the "Security Agreement")); and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quit claims and relinquishes unto the Grantor (without recourse and without any representation or warranty) the security interest in the Trademarks set forth on Schedule A granted to Agent by the Grantor pursuant to the Security Agreement, which security interest was duly recorded on November 20, 2007, at Reel 3664, Frame 0794 in the United States Patent and Trademark Office.
