TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of June 29, 2012, is entered into between Standard & Poor's Financial Services LLC, a limited liability company formed under the laws of the State of Delaware ("Grantor"), and S&P/Dow Jones Indices LLC, a limited liability company formed under the laws of the State of Delaware ("Secured Party").

WITNESSETH:

WHEREAS, reference is made to that certain MH Brand License Agreement, dated as of the date hereof (the "MH Brand License Agreement"), by and between Grantor and Secured Party relating to the MH Licensed Trademarks (as defined in the MH Brand License Agreement);

WHEREAS, Grantor is the owner of all the MH Licensed Trademarks;  
and

WHEREAS, Grantor acknowledges that the use of the MH Licensed Trademarks by Secured Party is essential and integral to Secured Party's business and that the MH Licensed Trademarks are integral to the value of that business.

NOW, THEREFORE, in consideration of the mutual promises and covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Definitions

The following terms shall have meanings as provided. Capitalized terms not otherwise defined herein shall have the meanings set forth in the MH Brand License Agreement.

"Bankruptcy Code" shall mean Title 11 of the United States Code as amended from time to time, and any successor statute or statutes.

"Collateral" shall mean (i) all of Grantor's right, title, and interest, whether now owned or hereafter acquired, in and to: (A) the MH Licensed Trademarks, along with all goodwill connected with the use thereof or symbolized thereby; (B) all registrations and applications for registration for the MH Licensed Trademarks; (C) all domain names that incorporate any of the MH Licensed Trademarks, including those listed in **Schedule I**, and (D) all files, records, certificates of registration, recordals, and other documentation to the extent relating to the foregoing in the possession or under the control of Grantor and (ii) all proceeds of the foregoing; provided that, notwithstanding the foregoing or any other provision in this Agreement, Collateral shall not include any Excluded Property.

“Effective Date” shall mean the date on which this Agreement has been fully executed.

“Event of Default” shall mean a rejection of the MH Brand License Agreement by Grantor or a trustee (or the equivalent of a trustee) in any bankruptcy or similar proceeding.

“Excluded Property” shall mean any intent-to-use trademark application filed in the PTO to the extent and only for so long as creation by Grantor of a security interest therein would result in the abandonment, invalidation or unenforceability thereof.

“Grantor” shall have the meaning set forth in the preamble hereto.

“Licensed Registrations” shall have the meaning set forth in the MH Brand License Agreement.

“Marks” shall have the meaning set forth in the MH Brand License Agreement.

“MH Brand License Agreement” shall have the meaning set forth in the recitals hereto.

“MH Licensed Trademarks” shall have the meaning set forth in the MH Brand License Agreement.

“PTO” shall mean the United States Patent and Trademark Office.

“Person” shall mean any natural person, joint venture, general or limited partnership, corporation, limited liability company, limited liability partnership, firm, association or organization or other legal entity.

“Secured Obligations” shall mean all of Grantor’s obligations under the MH Brand License Agreement and any damages incurred by Secured Party as a result of a breach by Grantor of such obligations, due to an Event of Default.

“Secured Party” shall have the meaning set forth in the preamble hereto.

“UCC” shall mean the Uniform Commercial Code as in effect from time to time in the State of New York.

2. Grant of Security Interest. To secure the Secured Obligations and any expenses incurred through the exercise of any remedies hereunder, Grantor hereby grants to Secured Party a first priority continuing security interest in and lien upon the Collateral. Grantor hereby authorizes Secured Party to file this Agreement and/or related filing statements with governmental offices in the United States and any subdivisions thereof and any other jurisdiction (foreign or domestic), including, but not limited to, the Delaware State Secretary of State and the PTO, in each case, for purposes of perfecting the security interest granted hereby in the Collateral.

3. Representations and Warranties. Grantor represents and warrants to Secured Party as follows:

(a) Grantor is duly formed, validly existing and in good standing under the laws of the jurisdiction of its organization;

(b) Grantor is authorized to enter into this Agreement, all actions necessary to that effect have been adopted in accordance with its organizational documents and are in full force and effect;

(c) **Schedule I** hereto sets forth a true and correct list (in all material respects) of all the Licensed Registrations included in the Collateral as of the Effective Date;

(d) Grantor owns and has rights in and, as to Collateral acquired by it from time to time after the date hereof, will own and have rights in, each item of Collateral pledged by it hereunder, free and clear of any and all liens or claims of others;

(e) The security interest in and lien on the Collateral granted to Secured Party hereunder constitutes (i) a legal and valid, first priority security interest in all the Collateral securing the performance of the Secured Obligations, and (ii) subject to the filing of this Agreement with the applicable Mark registries in applicable jurisdictions, a perfected security interest in all the Collateral; provided that additional filings with the relevant Mark registries may be required to perfect Secured Party's lien in Mark applications and registrations acquired by Grantor after the date hereof; and

(d) There is no effective financing statement or other document or instrument now executed, or on file or recorded in any public office, granting a security interest in or otherwise encumbering any part of the Collateral, other than those in favor of Secured Party.

4. Covenants. Grantor covenants and agrees with Secured Party that from and after the date of this Agreement that: (a) whenever Grantor, directly or through any agent, licensee (other than Secured Party) or designee, files an application for the registration of any MH Licensed Trademarks that constitute Collateral hereunder with the PTO or any similar office or agency within or outside the United States or wherever Grantor receives any additional MH Licensed Trademarks that constitute Collateral hereunder, Grantor will report such filing to Secured Party within sixty (60) days after such filing or receipt occurs; (b) Grantor will promptly execute, deliver, file and record all further instruments, endorsements and other documents, and take such further action as reasonably requested by Secured Party that is reasonably necessary for the perfection of the security interest of Secured Party hereunder; (c) Grantor shall not change its name, chief executive office, organizational structure or jurisdiction of organization without taking all action reasonably satisfactory to Secured Party as Secured Party may reasonably request to maintain the security interest of Secured Party in the Collateral intended to be granted hereby as fully perfected with the same or better priority and in full force and effect (it being agreed that Secured Party shall have no right to prevent Grantor from changing its name, chief executive office, organizational structure or jurisdiction of organization if the

foregoing obligations are satisfied); and (d) Grantor shall not transfer, sell, license, assign, encumber or otherwise dispose of Grantor's interest in any of the MH Licensed Trademarks or abandon, dedicate to the public, or permit to lapse any of the MH Licensed Trademarks.

5. Expenses. Except as set forth in Sections 6(e) and 9, allocation of costs and expenses with respect to the Security Agreement are set forth in Section 6.21 of the Contribution Agreement.

6. Rights and Remedies Upon an Event of Default.

(a) If any Event of Default shall have occurred and be continuing, then and in every such case, subject to any mandatory requirements of applicable law then in effect, Secured Party, in addition to other rights and remedies provided for herein and any rights now or hereafter existing under applicable law, shall have all rights and remedies as a secured party under the UCC (including, but not limited to, all rights of Secured Party under Section 9-620 of the UCC and Grantor hereby agrees that it shall consent and not object to all actions taken by Secured Party under such section (or otherwise)) and the Bankruptcy Code in all relevant jurisdictions and may: (i) personally, or by agents or attorneys, immediately take possession of the Collateral or any part thereof, from Grantor or any other Person who then has possession of any part thereof, with or without notice or process of law, and (ii) credit bid, sell, license, assign or otherwise liquidate, or direct Grantor to sell, license, assign or otherwise liquidate, any or all of the Collateral and take possession of the proceeds of any such sale, license, assignment or liquidation.

(b) Any Collateral repossessed by Secured Party under or pursuant to Section 6(a) may be sold, licensed, assigned, leased or otherwise disposed of under one or more contracts or as an entirety, and without the necessity of gathering at the place of sale the property to be sold, licensed, assigned, leased or otherwise disposed of, and in general in such terms as Secured Party may, in compliance with any mandatory requirements of applicable law, determine to be commercially reasonable.

(c) Upon the occurrence and continuance of an Event of Default, Secured Party shall have the right at any time to make any payments and do any other acts Secured Party may deem necessary to protect its security interest in the Collateral, including, without limitation, the rights to pay, purchase, contest or compromise any encumbrance, charge or lien which, in the judgment of Secured Party appears to be prior to or superior to the security interests granted hereunder in the Collateral, and appear in and defend any action or proceeding purporting to affect its security interests in, and/or the value of, the Collateral. However, Secured Party shall have no obligation to make any of the foregoing payments or perform any of the foregoing acts.

(d) Upon the occurrence and during the continuance of an Event of Default, Grantor hereby irrevocably authorizes and appoints Secured Party, and any officer or agent thereof as Grantor's attorney-in-fact, with full authority in the place and stead of Grantor and in the name of Grantor in Secured Party's discretion, to take any action and to execute any instrument that Secured Party may deem necessary or advisable for the

purpose of carrying out the terms of this Agreement and to exercise all of the following powers with respect to the Collateral, which powers, being coupled with an interest, shall be irrevocable: (i) ask for, demand, collect, bring suit, recover, compromise, administer, accelerate or extend the time of payment, compromise, receive and give acquittance and receipts for moneys due and to become due under or in respect of any of the Collateral; (ii) receive, take, endorse, negotiate, sign, assign and deliver and collect any checks, notes, drafts or other instruments, documents and chattel paper, in connection with clause (i) above; (iii) convey any Collateral to any purchaser thereof; (iv) record any instruments contemplated under the terms thereof; (v) make any payments or take any actions under Section 6(c) hereof; and (vi) file any claims or take any action or institute any proceedings that Secured Party may reasonably deem necessary or desirable for the collection of any of the Collateral or otherwise to enforce the rights of Secured Party with respect to any of the Collateral. Secured Party's authority under this Section 6(d) shall include, without limitation, the authority to execute and give receipt for any certificate of ownership or any document, transfer title to any of the Collateral, execute as Secured Party's attorney-in-fact all financing statements or any other documents deemed necessary or appropriate to preserve, protect or perfect the security interest in the Collateral and to file the same, prepare, file and execute as Secured Party's attorney-in-fact any notice of lien, assignment or satisfaction of lien or similar document in connection with any of the Collateral and prepare, file and execute as Secured Party's attorney-in-fact a proof of claim in bankruptcy or similar document against any creditor of Grantor, and to take any other actions arising from or incident to the rights, powers and remedies granted to Secured Party in this Agreement.

(e) Grantor agrees to pay all costs with respect to the enforcement of any of Secured Party's rights in this Section 6 following an Event of Default.

(f) Notwithstanding anything to the contrary in this Agreement, (A) Secured Party shall have no right or remedy with respect to, and shall not be entitled to take any action which could reasonably be expected to impair, affect or interfere with, (i) Grantor's rights to, or ownership of, any of its assets other than the Collateral, including without limitation any Marks other than those included in the Collateral, or (ii) the MH Brand License Agreement(s) or any of MH's or any other licensees' rights thereunder, (B) Secured Party agrees that the sale, assignment, transfer or any other foreclosure action with respect to any of the Collateral by Secured Party shall not impede, impair or invalidate the MH Brand License Agreement with respect to such Collateral, and (C) Secured Party agrees that to the extent it has exhausted its remedies against the Collateral in accordance with this Section 6 but the Secured Obligations have not been fully satisfied, any remaining claim that Secured Party may have shall be calculated in accordance with, and its rights with respect to any such claim, shall be as provided for in the MH Brand License Agreement, the applicable provisions of which are deemed incorporated hereby as if fully set forth herein.

7. Rights and Remedies Other than Upon an Event of Default. Other than upon the occurrence of an Event of Default, Secured Party shall have no right to seek or recover monetary damages against Grantor or any of its Affiliates in connection with this

Agreement. Notwithstanding anything contained herein, Secured Party shall have the right to seek specific performance upon the breach of any of Grantor's obligations hereunder.

8. Termination. This Agreement shall automatically terminate and Secured Party's security interest shall be released without any further action being required in the event that the MH Brand License Agreement terminates pursuant to its terms; provided that Section 6(f)(C) shall survive such termination. Upon such event, Secured Party shall execute and deliver any agreements, filings, or other documents reasonably requested by Grantor to evidence such release and Secured Party hereby authorizes Grantor to file or record such documents on its behalf.

9. Modification of Agreement. This Agreement or any provision hereof may not be amended, changed, waived, or terminated except by mutual written agreement of the parties. Grantor additionally agrees to execute any additional agreement or amendment hereto, which is consistent with and does not modify or change the terms and conditions of this Agreement, as may be reasonably requested by Secured Party from time to time to subject any such owned or subsequently acquired right, title or interest in any of the Collateral to the liens and perfection created or contemplated hereby; provided that any actions taken under this Section 9 will be at the sole cost and expense of Secured Party.

10. Notices. All notices and other communications hereunder shall be in writing and shall be given as set forth in the MH Brand License Agreement.

11. Headings. The section headings of this Agreement are for reference purposes only and are to be given no effect in the construction or interpretation of this Agreement.

12. Severability. In the event that any provision (or portion thereof) of this Agreement is determined by a court or arbitration to be unenforceable as drafted by virtue of the scope, duration, extent, or character of any obligation contained in this Agreement, it is Grantor and Secured Party's intention that such provision (or portion thereof) shall be construed in a manner designed to effectuate the purposes of such provision to the maximum extent enforceable under such applicable law. Grantor and Secured Party shall enter into whatever amendment to this Agreement as may be necessary to effectuate such purposes.

13. Interpretation. All terms not defined herein or in the MH Brand License Agreement shall have the meaning set forth in the UCC, except where the context otherwise requires. To the extent a term or provision of this Agreement conflicts with the MH Brand License Agreement and is not dealt with herein with more specificity, the MH Brand License Agreement shall control with respect to the subject matter of such term or provision. Acceptance of or acquiescence in a course of performance rendered under this Agreement shall not be relevant in determining the meaning of this Agreement even though the accepting or acquiescing party had knowledge of the nature of the performance and opportunity for objection.

14. Delays; Partial Exercise of Remedies. No delay or omission of Secured Party to exercise any right or remedy hereunder, whether before or after the happening of any Event of Default, shall impair any such right or shall operate as a waiver thereof or as a waiver of any such Event of Default. No single or partial exercise by Secured Party of any right or remedy shall preclude any other or further exercise thereof, or preclude any other right or remedy.

15. Governing Law. THIS AGREEMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK WITHOUT REFERENCE TO OR INCLUSION OF THE PRINCIPLES OF CHOICE OF LAW OR CONFLICTS OF LAW OF THAT JURISDICTION. ANY DISPUTE ARISING OUT OF OR RELATING TO THIS AGREEMENT SHALL BE BROUGHT AND PROSECUTED IN ACCORDANCE WITH SECTION 14.6 OF THE MH BRAND LICENSE AGREEMENT.

16. Successors and Assigns. This Agreement shall be binding upon and inure to the benefit of the parties, all future holders of the Collateral and their respective successors and assigns, except that (i) Grantor may not assign or transfer any of its rights or obligations under this Agreement without the prior written consent of Secured Party, and (ii) Secured Party may not assign or transfer any of its rights or obligations under this Agreement without the prior written consent of Grantor other than in connection with a permitted assignment of the MH Brand License Agreement.

17. Counterparts. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original and all of which together shall constitute one instrument.


