Background

Mercedes García DIEZ, an individual of Spanish citizenship, with an address at c/ Massamagrell, nº 9, Elche E-03203, Spain ("Assignor"), has adopted, owns, and is using the mark "MTNG" (the "Mark") in connection with the following goods and services:

"Leather and imitation leather; Goods made of leather and imitation leather, namely, handbags, wallets, and bags in the nature of all-purpose carrying bags, all-purpose sport bags, belt bags, bags for umbrellas, clutch bags, duffel bags, and overnight bags; Animals skins and hides; Trunks and suitcases; Umbrellas, sunshades in the nature of parasols and sun umbrellas; Walking sticks, whips, and saddlery," in International Class 18;

"Ready-made wear for women, men and children, namely, belts, gloves, jackets, sweaters, mittens, overcoats, shirts, t-shirts, pants, and undergarments; footwear, namely, boots, shoes, and sandals; headgear, namely, hats and caps," in International Class 25; and

"Advertising and business management; Business administration; Providing office functions," in International Class 35.;

Assignor owns a federal application to register the Mark on the Principal Register of the United States Patent and Trademark Office in connection with the above-mentioned goods and services, U.S. Application Serial No. 77/890,794, in International Class 18, 25 and 35, filed on December 10, 2009 (the "Application"); and

AYMERICH INVER, S.L., a Sociedad Limitada (S.L.) of Spain, with its principal place of business at Calle Severo Ochoa, 36, Elche Parque Industrial, E-03203 ELCHE (Alicante), Spain ("Assignee"), desires to acquire the Mark, all its associated goodwill, and the Application.


