## RELEASE OF SECURITY INTEREST

This Release of Security Interest is made the 14<sup>th</sup> day of June, 2012, by and between Wells Fargo Bank, National Association, a national banking association, with an address of One Boston Place, 18<sup>th</sup> Floor, Boston MA 02108, successor by merger to Congress Financial Corporation, in its capacity as agent for and on behalf of the lenders (in such capacity, "Agent") under the Fourth Amended and Restated Loan and Security Agreement dated July 14, 2011 (the "Loan Agreement"), by and among Charming Shoppes, Inc., a Pennsylvania corporation, certain of its subsidiaries party thereto, the lenders party thereto (the "Lenders"), Agent, and certain other parties thereto, in favor of Catherines Woman Michigan, Inc., formerly known as Modern Woman, Inc., a Delaware corporation with an address of 3750 State Road, Bensalem, PA 19020 ("Debtor").

### RECITALS

A. Debtor is the owner of certain trademarks (collectively, the "Trademarks"), including but not limited to the trademark and corresponding registrations therefor listed on the attached Schedule A (collectively, the "Scheduled Trademark"); and

B. Pursuant to Section 5.1 of the Loan Agreement and the Trademark Collateral Assignment and Security Agreement, dated as of August 16, 2001 (the "Trademark Agreement"), between Modern Woman, Inc. and Congress Financial Corporation, which was recorded with the United States Patent and Trademark Office ("USPTO") on August 30, 2001 at Reel Number 2358/0407 (the "Recording"), Debtor granted a security interest in the Trademarks (including the Scheduled Trademark) to Agent; and

C. In connection with the termination of the Loan Agreement on the date hereof, Debtor has requested that Agent release all of its right, title, and interest in and to the Trademarks.

### AGREEMENT

Accordingly, for good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, Agent does hereby release any and all right, title, and interest (including all security interests) it may have in and to the Trademarks (including the applications and registrations therefor and the goodwill associated therewith) pursuant to the Loan Agreement, the Trademark Agreement, the Recording, or otherwise.

Agent will execute such other documents and instruments, and take other such actions (at the expense of Debtor) as Debtor may reasonably request to evidence this termination and release and the release of any security interest Agent may have in and to the Trademarks.


