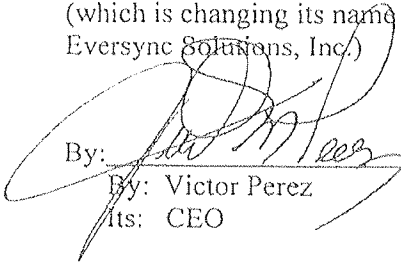

Revinetix, Inc., a Utah corporation (the "*Corporation*"), formed under the Utah Revised Business Corporation Act (the "*URBCA*"), adopts the following Articles of Amendment to its Articles of Incorporation, as previously amended and restated (the "*Articles*"):

1. Article I of the Articles is hereby amended and restated in its entirety to read as follows:
"*The name of the Corporation is Eversync Solutions, Inc.*"
2. The amendment to the Articles set forth above was approved effective as of March 8, 2012, by the shareholders of the Corporation at the Corporation's Annual meeting where a quorum was present.
3. Upon the adoption of the foregoing amendment to the Articles, the Corporation had two classes of shares outstanding (a) Common Stock, of which 5,499,824 shares were outstanding and (b) Series A Preferred Stock, of which 7,240,000 shares were outstanding.
4. Each outstanding share of Common Stock and Series A Preferred Stock was entitled to one vote on the foregoing amendment and voted together as a single class. 3,703,123 shares of Common Stock and 5,330,920 shares of Series A Preferred Stock voted in favor of the foregoing amendment, which is sufficient to approve the foregoing amendment to the Articles.
