NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARK RIGHTS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Release"), effective as of July 9, 2012 is made ALLY COMMERCIAL FINANCE LLC, formerly known as GMAC COMMERCIAL FINANCE LLC, a Delaware limited liability company (the "Agent"), in favor of CONNEY SAFETY PRODUCTS, LLC, a Delaware limited liability company (the "Company"), pursuant to that certain Loan and Security Agreement, dated as of October 1, 2007 (the "Credit Agreement") among the Company, the other Loan Parties from time to time party thereto, the Agent, and the Lenders from time to time party thereto and the other agents party thereto.

W I T N E S S E T H:

WHEREAS, in connection with the Credit Agreement, the Company executed and delivered a Grant of Security Interest in Trademarks, dated as of October 1, 2007, in favor of the Agent (the "Security Agreement");

WHEREAS, pursuant to the Credit Agreement, the Company pledged and granted to the Agent for the benefit of the Lenders a continuing first priority security interest in all of its intellectual property, including the trademarks and trademark applications set forth on Schedule A attached hereto (the "Released Trademarks");

WHEREAS, the Agent recorded its security interest in the Released Trademarks under the Security Agreement in the Trademark Division of the United States Patent and Trademark Office on October 9, 2007, at Reel 003638, Frame 0450;

WHEREAS, the Company has requested that the Agent release any and all right, title and interest it may have in the Released Trademarks pursuant to the Security Agreement and the Credit Agreement, and the Agent has agreed to do so; and

WHEREAS, the Agent has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent agrees, for the benefit of the Company, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Credit Agreement and Security Agreement, as applicable (it being understood that, in the event of any conflict, such terms shall have the meanings provided or provided by reference in the Credit Agreement).

SECTION 2. Release of Security Interest. The Agent does hereby irrevocably release, relinquish and discharge its security interest and any other rights in, to and under the Released Trademarks and all right, title and interest of the Company in the Released Trademarks are hereby reassigned to the Company.

SECTION 3. Purpose. This Release has been executed and delivered by the Agent for the purpose of recording this Release with the United States Patent and Trademark Office. This Release has been granted to the Company in connection with the Credit Agreement and is expressly subject to the terms and conditions thereof.

SECTION 4. Counterparts. This Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
