**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of July 12, 2012, is made by Deutsche Bank Trust Company Americas, as assignee of Canadian Imperial Bank of Commerce ("Collateral Agent"), in favor of Phillystran, Inc., now known as WireCo WorldGroup Inc. ("WireCo") as follows:

WITNESSETH

WHEREAS, pursuant to the U.S. Intellectual Property Security Agreement, dated January 25, 2010 (the "Security Agreement"), and recorded with The United States Patent and Trademark Office on May 17, 2010 at Reel/Frame No. 4207/0768, WireCo granted Collateral Agent a security interest in and to all of its right, title and interest in its trademarks and all applications and registrations therefor, including goodwill (the "Trademark Collateral");

NOW, THEREFORE, Collateral Agent, without recourse, representation or warranty and at WireCo's sole cost and expense, hereby RELEASES all of its right, title and interest in and to the Trademark Collateral, including without limitation the trademarks set forth in Schedule A and any other collateral described in the Security Agreement.


Collateral Agent agrees to provide WireCo with any information and additional authorization necessary to effect the release of Collateral Agent's security interest in the released Trademark Collateral without recourse, representation or warranty and at WireCo's sole cost and expense.
