**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of July 12, 2012, is made by Deutsche Bank Trust Company Americas, as assignee of Canadian Imperial Bank of Commerce ("Collateral Agent"), in favor of Wire Rope Corporation of America, Inc., now known as WireCo WorldGroup Inc. ("WireCo") as follows:


