**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of July 12, 2012, is made by HSBC Business Credit (USA) Inc. ("Collateral Agent"), in favor of Phillystran, Inc., now known as WireCo WorldGroup Inc. ("WireCo") as follows:

NOW, THEREFORE, Collateral Agent, without recourse, representation or warranty and at WireCo's sole cost and expense, hereby RELEASES all of its right, title and interest in and to the Trademark Collateral, including without limitation the trademarks set forth in Schedule A and any other collateral described in the Security Agreement.

Collateral Agent agrees to provide WireCo with any information and additional authorization necessary to effect the release of Collateral Agent's security interest in the released Trademark Collateral.
