**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release") is made as of July 10, 2012 ("Effective Date") by **COMERICA BANK**, a Texas banking corporation, as Lender ("Grantee"), in favor of **POOF-SLINKY, INC.** (successor by merger to James Industries, Inc.) ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Patent, Trademark and Copyright Security Agreement dated July 28, 2003 (the "Security Agreement"), Grantor granted Grantee a security interest in and to certain trademarks and other intellectual property (the "Trademark Collateral");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on March 24, 2004 at Reel 2816, Frame 0193; and

WHEREAS, Grantee now desires to release its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

Grantee hereby terminates, releases and discharges its security interest in the Trademark Collateral granted pursuant to the Security Agreement, including, without limitation, its security interest in the trademarks listed in Exhibit A granted pursuant to the Security Agreement, and reassigns to Grantor all right, title and interest of Grantee in the Trademark Collateral pursuant to the Security Agreement.


