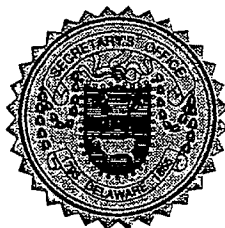


In accordance with Section 265 of the Delaware General Corporation Law (the "DGCL"), this Certificate of Conversion, dated as of August 3, 2005, is hereby duly executed and filed by Paul Förster, as an authorized person of Indeed Search, LLC, a Texas limited liability company (the "Company"), in order to convert the Company into a corporation incorporated under the laws of the State of Delaware. The corporation formed upon such conversion shall be known as Indeed, Inc. (the "Corporation").

1. The Company is a Texas limited liability company under the name Indeed Search, LLC, and its articles of organization were filed with the Secretary of State of the State of Texas on October 8, 2004.
2. The name of the Company immediately prior to the filing of this Certificate of Conversion is Indeed Search, LLC.
3. The name of the Corporation into which the Company shall be converted as set forth in its certificate of incorporation is Indeed, Inc.
4. The conversion of the Company to the Corporation has been duly authorized and approved in accordance with the provisions of Section 10.08 of the Texas Limited Liability Company Act and Section 265(h) of the DGCL.
5. The conversion shall be effective upon the filing of this Certificate of Conversion and the certificate of incorporation of the Corporation with the Secretary of State of the State of Delaware and the filing of the Articles of Conversion with the Secretary of State of the State of Texas.
6. For federal income tax purposes, the conversion shall be treated as if the Company contributed its assets and liabilities to the Corporation in consideration for the Corporation's issuance of stock, and the Company distributed the Corporation stock to its members in complete liquidation of the Company. The conversion effected pursuant to this Certificate of Conversion and the upcoming equity financing are intended to be treated as a single transaction within the meaning of Section 351 of the Internal Revenue Code of 1986, as amended.
