## TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (as amended, restated, supplemented, or otherwise modified from time to time, the "Trademark Security Agreement") dated as of June 18, 2012, is made by the Persons listed on the signature pages hereof (collectively, the "Grantors") in favor of SunTrust Bank, as administrative agent (together with its successors and assigns in such capacity, the "Administrative Agent") for the Lender Group (as defined in the Credit Agreement referred to below).

WHEREAS, pursuant to that certain Credit Agreement dated as of June 18, 2012 (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), by and among CANDY INTERMEDIATE HOLDINGS, INC., a Delaware corporation ("Intermediate Holdings"), F&S HOLDINGS 1, INC., a Delaware corporation ("F&S"), CANDY MERGER SUB, INC., a Delaware corporation ("F&S Merger Sub"), FERRARA PAN CANDY CO., INC., an Illinois corporation ("Ferrara"), FPCC MERGER SUB, INC., an Illinois corporation ("Ferrara Merger Sub"), each of the other Persons party thereto from time to time as borrowers (together with Intermediate Holdings, F&S, F&S Merger Sub, Ferrara, and Ferrara Merger Sub, each, a "Borrower," and, collectively, the "Borrowers"), FERRARA CANDY COMPANY, a Delaware corporation ("Holdings"), the other Persons party thereto from time to time as guarantors, the financial institutions party thereto from time to time as lenders (collectively, the "Lenders"), and the Administrative Agent, the Lenders and the Issuing Bank have agreed to make certain extensions of credit and other financial accommodations available to the Borrowers pursuant to the terms and conditions thereof;

WHEREAS, as a condition precedent to the Lenders' making such extensions of credit and other financial accommodations available to the Borrowers, the Grantors and the Administrative Agent have executed and delivered that certain Security Agreement dated as of June 18, 2012 (as amended, restated, supplemented, or otherwise modified from time to time, the "Security Agreement"); and

WHEREAS, under the terms of the Security Agreement, the Grantors have granted to the Administrative Agent, for the benefit of each member of the Lender Group, a security interest in and lien on, among other property, certain intellectual property of the Grantors, and have agreed as a condition thereof to execute this Trademark Security Agreement for recording with the U.S. Patent and Trademark Office and other governmental authorities.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

SECTION 1. Terms. Terms defined in the Credit Agreement and Security Agreement, as applicable, and not otherwise defined herein are used herein as defined in the Credit Agreement and Security Agreement.

SECTION 2. Grant of Security. Each Grantor hereby unconditionally grants, pledges, and collaterally assigns to the Administrative Agent, and its successors and assigns, for the benefit of the Lender Group a continuing security interest in, security title to, and lien on all of such

Grantor's right, title and interest in, to or under the Trademarks, including the Trademarks set forth on Schedule A attached hereto.

SECTION 3. Security for Obligations. The grant of a security interest in the Trademarks by each Grantor under this Trademark Security Agreement is made to secure the payment, performance, and observance in full of all of the Secured Obligations.

SECTION 4. Recordation. Each Grantor authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Trademark Security Agreement.

SECTION 5. Execution in Counterparts. This Trademark Security Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery by telecopier or by electronic .pdf copy of an executed counterpart of a signature page to this Trademark Security Agreement shall be effective as delivery of an original executed counterpart of this Trademark Security Agreement.

SECTION 6. Security Agreement. This Trademark Security Agreement has been entered into in conjunction with the provisions of the Security Agreement. Each Grantor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Administrative Agent with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein.
