## AMENDMENT NO. 1 TO TRADEMARK SECURITY AGREEMENT

This Amendment No. 1 to Trademark Security Agreement, dated as of May 18, 2012 (this “**Amendment**”), to the Trademark Security Agreement, dated as of December 16, 2010 (as heretofore amended, the “**Trademark Security Agreement**”), by and among certain of the Grantors and FSJC III, LLC, a Delaware limited liability company (together with its successors and assigns, the “**Collateral Agent**”), is entered into by and among Emerald Performance Materials, LLC, a Delaware limited liability company (“**Borrower**”), EPM Polymer Additives Holding Corp., EPM Hilton Davis Holding Corp., EPM Kalama Chemical Holding Corp., EPM Foam Control Holding Corp., EPM Carolina Chemical Holding Corp. and EPM Specialty Polymers Holding Corp. (each a “**Parent**” and, collectively, the “**Parents**”), Emerald Performance Holding Group, LLC, a Delaware limited liability company (“**Holdings**”), the Subsidiary Guarantors (such term and each other capitalized term used but not defined herein having the meaning given to it in the Credit Agreement, as defined below) (and, together with Holdings, Parents and Borrower, the “**Grantors**”), and FSJC III, LLC.

### RECITALS

A. WHEREAS, pursuant to that certain Amended and Restated Senior Secured Second Lien Term Loan Agreement with AIR-O Option<sup>SM</sup>, dated as of May 18, 2012 (as amended, restated, supplemented or otherwise modified from time to time, including all exhibits schedules thereto, the “Credit Agreement”), among Grantors, the lenders, from time to time, party thereto, and FSJC III, as administrative agent for the Lenders (in such capacity, together with any successor administrative agent, the “Administrative Agent”), the Lenders are willing to make certain financial accommodations available to Borrower from time to time pursuant to the terms and conditions thereof.

B. WHEREAS, certain of the Grantors and Collateral Agent are party to that certain Trademark Security Agreement, dated as of December 16, 2010;

C. WHEREAS, Grantors and Collateral Agent are desirous of making specific amendments to the Trademark Security Agreement, as and to the limited extent expressly set forth herein.

D. WHEREAS, This Amendment shall constitute a Loan Document and these Recitals shall be construed as part of this Amendment.

NOW THEREFORE, for good and valuable consideration the sufficiency of which is hereby acknowledged, Grantors and Collateral Agent hereby agree as follows:

1. Amendments. Schedule I to the Trademark Security Agreement. The Trademark Security Agreement is hereby amended by deleting Schedule I attached thereto and replacing it in its entirety with Schedule I attached hereto.

2. Reference to and Effect Upon the Trademark Security Agreement.

2.1. Except for the specific amendments in Section 2 above, the Trademark Security Agreement shall remain in full force and effect and is hereby ratified and confirmed.

2.2. The execution, delivery and effect of this Amendment shall be limited precisely as written and shall not be deemed to (i) be a consent to any waiver of any term or condition or any amendment or modification of any term or condition of the Trademark Security Agreement (except for the specific amendments set forth in Section 2 above) or any other Loan Document or (ii) prejudice any right, power or remedy which the Collateral Agent now has or may have in the future under or in connection with the Trademark Security Agreement or any other Loan Document.

3. Acknowledgment and Consent of Grantors. Each Grantor hereby consents to this Amendment and hereby confirms and agrees that (a) each Loan Document to which it is a party is, and shall continue to be, in full force and effect and each is hereby ratified and confirmed in all respects, and (b) the Liens granted by such Grantor on all Collateral of such Grantor continue to secure the payment of all of the Obligations.

4. Counterparts. This Amendment may be executed in any number of counterparts, each of which when so executed shall be deemed an original but all such counterparts shall constitute one and the same instrument. Delivery of an executed counterpart of a signature page to this Amendment by telecopier or electronic transmission shall be as effective as delivery of a manually executed counterpart signature page to this Amendment.

5. GOVERNING LAW. THIS AMENDMENT SHALL BE GOVERNED BY AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH THE INTERNAL LAWS (AS OPPOSED TO CONFLICTS OF LAW PROVISIONS) OF THE STATE OF NEW YORK.

6. Headings. Section headings in this Amendment are included herein for convenience of reference only and shall not constitute a part of this Amendment for any other purpose.


