ARTICLES OF DOMESTICATION
OF
PARAGON VISION SCIENCES, INC.

1. The name of the Corporation is Paragon Vision Sciences, Inc.
2. The corporation was originally incorporated in the State of Delaware as Paragon Acquisition Corporation and the date of its incorporation in that state was September 29, 1995.
3. The official in charge of corporate filings in the jurisdiction in which the corporation was previously incorporated will be provided with a certified copy of the Articles of Domestication filed in the State of Arizona.
4. The purpose for which the corporation is organized is to engage in any or all lawful business activity. The character of business which the corporation initially intends to actually conduct in the State of Arizona is to engage in the design, manufacture, marketing, and sales of contact lens-related products.
5. The aggregate number of shares that the corporation shall have authority to issue is Two Hundred Thousand (200,000) common shares, all of which shares shall be of a single class and shall have a par value of \$0.01 per share.
6. The name and street address in Arizona of the initial statutory agent of the corporation are: Ted H. Hinderaker, Hinderaker & Rauh, PLC, 2401 E. Speedway Blvd., Tucson, Arizona, 85719. The street address of the initial known place of business of the corporation in Arizona is: 947 East Impala, Mesa, Arizona 85204.
7. The number of directors constituting the current board of directors of the corporation is: three (3). The names and addresses of the persons who are to serve as directors until the next annual meeting of shareholders, or until their successors are elected and qualified, are:

To the fullest extent permitted by law, the liability of a director or former director to the corporation or its shareholders for any action taken or the failure to take any action shall be eliminated. No repeal, amendment or modification of this article shall modify the effect hereof with respect to any act or omission of a director occurring prior to such repeal, amendment or modification.

9. The corporation shall indemnify any person who incurs an expense by reason of his or her position as an officer, director or agent of the corporation. This indemnification shall be mandatory in all circumstances under which indemnification is permitted by law.

10. These Articles of Domestication have been adopted in accordance with Arizona Revised Statutes Section 10-221. They were adopted by the board of directors of the corporation on June 21, 2001 and by the shareholders of the corporation on June 21, 2001.

11. Upon transfer of domicile of the corporation to Arizona, the Corporation accepts and will be subject to the laws of the State of Arizona.

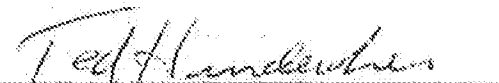
