- (c) the right to sue for all past, present and future infringement of the said Marks by third parties;



- (d) the rights of the Assignor in and to any Registrations of the said Marks (including the Trademarks set forth on the attached Schedule) in the United States and all other countries of the world where Registrations have been made; and
- (e) all copyright in the Marks.


