RELEASE OF SECURITY INTERESTS AND
ASSIGNMENT OF COPYRIGHTS AND TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN AND ASSIGNMENT OF COPYRIGHTS AND TRADEMARKS ("Assignment") made as of the 13 day of July, 2012, by M&T BANK, as successor to Allfirst Bank ("Assignor"), in favor of THE BACHMAN COMPANY, a Pennsylvania Corporation ("Assignee").

BACKGROUND

A. Assignee is the owner of certain copyrights, including certain registered copyrights as reflected on the records of the United States Copyright Office, all as more fully set forth on Exhibit "A" attached hereto and made a part hereof (collectively, the "Copyrights").

B. Assignee is the owner of certain trademarks and all goodwill therein, including certain registered trademarks and trademark applications as reflected on the records of the United States Patent and Trademark Office, all as more fully set forth on Exhibit "B" attached hereto and made a part hereof (collectively, the "Trademarks").

C. In connection with certain credit accommodations heretofore established by Assignor in favor of Assignee, Assignee, among other things, granted to Assignor a lien on and security interest in the Copyrights and the Trademarks.

D. The credit accommodations heretofore established by Assignor in favor of Assignee have been terminated and cancelled. Accordingly, Assignor is hereby releasing its lien on, and all of Assignor's right, title and interest (if any) in and to, the Copyrights and the Trademarks heretofore granted by Assignee to Assignor and is assigning all of its right, title and interest in and to the Copyrights and the Trademarks (if any) to Assignee pursuant to this Assignment.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor, intending to be legally bound hereby, covenants and agrees as follows:

1. Incorporation of Background. The Background provisions set forth above (including, without limitation, all defined terms set forth therein) are hereby incorporated herein by reference and made a part of this Assignment as if set forth in their entirety in this Section 1.

2. Release and Assignment. Assignor hereby irrevocably and unconditionally (a) releases, discharges, and relinquishes its lien on and security interest in all of the Copyrights and the Trademarks and (b) assigns, transfers, conveys and sets over unto the Assignee any and all of Assignor's right, title and interest, if any, in, to and under the Copyrights and the Trademarks.

3. Further Actions. From time to time after the date hereof, and without further consideration, at the request and sole cost and expense of Assignee, Assignor shall promptly take such actions and execute and deliver such documents and instruments as Assignee or their counsel may reasonably request in order to perfect and record Assignee's ownership rights in the Copyrights and the Trademarks.
