CONFIRMATORY ASSIGNMENT OF TRADE-MARKS

WHEREAS Bluberi Jeux et technologies inc. AKA Bluberi Gaming Technologies Inc. NOW THEREFORE, in consideration of the sum of \$1 and other good and valuable consideration the receipt and adequacy of which is hereby acknowledged, the Assignor by these present does hereby assign and transfer unto the Assignee, its successor and assigns, all of the Assignor's right, title, interest and goodwill in and to the Trade-marks, together with all right of action resulting from any adverse use of the Trade-marks or any confusingly similar trade-mark, prior to the effective date of this assignment, and the right to claim such relief as is appropriate, together with the goodwill of the business carried on in association with the Trade-Marks, the same to be held by the Assignee, its successor and assigns as fully and effectually as they would have been held by the Assignor, had this assignment and transfer not be made.

Upon execution, the Assignor undertakes to record this assignment with the US Patent and Trademark Office at its expense, to protect Assignee's rights in the Trade-marks and will deliver evidence thereof to Assignee, without any further obligation for Assignor.

The Assignment is effective on May 14, 2012.
