AGREEMENT FOR TRANSFER OF INTELLECTUAL PROPERTY RIGHTS

This Agreement is made this 11 february of 2002 by and between:

EMILIO PUCCI S.R.L. a company organized and existing under the laws of Italy, formerly named PERLA S.r.l. having its registered office at Via dei Pucci n. 6, 50122 Firenze, Italy, represented for the purposes hereof by PIETRO PASOTTI power of attorney inclose "A" (hereinafter referred as the "Assignor"), on the one hand,

and EMILIO PUCCI INTERNATIONAL B.V., a company organized and existing under the laws of the Netherlands having its registered office at 1411 CT Naarden, Cattenhagestraat 8a, The Netherlands, represented for the purposes hereof by Laudomia Pucci di Barsento President, provide of the powers confer from Board of Directors during the meeting 26 jannuary 2002 (hereinafter referred as "The Assignee") on the other hand.

## WHEREAS

The Assignor has decided to transfer to the Assignee, who has accepted, the intellectual property rights worldwide (hereinafter the "I.P. Rights") vested by virtue of the merger between PERLA S.r.l. and EMILIO PUCCI S.r.l. of 18 april 2001 referred in Exhibit "B", according to the following Terms and Conditions.

The above transfer concerns all I.P. Rights worldwide, including but not limited to patents, designs, know-how, copyright, trade names, and trademarks in particular the trademark registrations and/or applications listed in Exhibit 2 (hereinafter the "Trademarks") for all goods and/or services claimed, as well as all priority, common law and similar trademark rights relating to the Trademarks.

## IT IS HEREBY AGREED AS FOLLOWS:

## 1. Premises and Exhibits

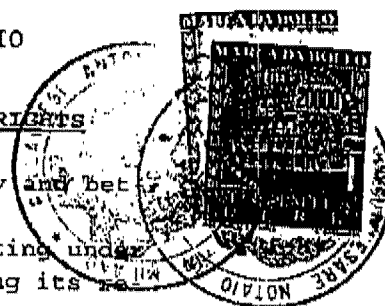
The above premises and attached Exhibits are integral part of the present Agreement.

## 2. Transfer

The Assignor hereby transfers to the Assignee, who accepts, the full and exclusive ownership of the I.P. Rights for a good and valuable consideration of Euros 16.620.000 (sixteen millions and six hundred and twenty) (equivalent to ITL 32.180.998.000) as payment in full.

The warranty given by the Assignor as to the I.P. Rights transferred is limited to their respective status as of the execution date of this Agreement and in particular shall not extend to the outcome of pending proceedings.

Upon execution hereof, the Assignee shall be subrogated in the Assignor's rights and duties in relation to the I.P. Rights.



### 3. Registration and Taxes

The registration of the present Agreement before any competent Authority including Trademark offices shall be done by the Assignee who shall bear any subsequent cost (including translation fees) and tax.

The parties undertake to register the present Agreement before an Italian Notary Public authorizing him to deliver certified copies thereof and to execute any further deed or document which may prove necessary or advisable in order to record this Agreement before any competent Authority including Trademark Offices.

The parties hereby grant sufficient power to the holder of an original or certified copy of this Agreement to attend to the recordal of this Agreement.

### 4. Governing Law and jurisdiction

This Agreement and all related rights and obligations shall be governed by and construed in accordance with the Laws of Italy.

Any proceeding and/or legal action arising out of, or in connection with, this Agreement shall be, in the absence of any possibility of amicable settlement between the parties, to the exclusive jurisdiction of the competent Court of Milano.

The Italian version shall prevail on the English version.

This act isn't subject IVA, ex law 633/72 Art. 7/4/E; is subject register fixed tax ex law 131/86 Art. 40.
