**RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release"), dated as of July 16, 2012, is made by DEUTSCHE BANK TRUST COMPANY AMERICAS, New York banking corporation (formerly known as Bankers Trust Company) ("Secured Party"), and is as follows:

WHEREAS, MOTEL 6 OPERATING L.P., a Delaware limited partnership ("Debtor"), and Secured Party are parties to that certain Trademark Security Agreement dated as of January 23, 1989 (the "Agreement"), which was recorded with The United States Patent and Trademark Office on February 17, 1989, in its records at Reel 0638, Frame 793; capitalized terms used but not defined herein will have the meaning given to them in the Agreement;


WHEREAS, pursuant to the Agreement, Debtor granted to, and created in favor of, Secured Party a continuing security interest in, and Lien on, all of the Trademark Collateral, including, without limitation, the Trademark Collateral described on Schedule I attached hereto and incorporated by reference herein; and

WHEREAS, Secured Party desires to release its rights and security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the Trademark Collateral and (ii) any and all other rights it may have under the Agreement.
