ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks ("Assignment"), effective as of July 5, 2012, is entered into by and between Planora Inc. (formerly known as Omega Optimisation Inc.), a corporation incorporated under the Laws of Canada ("Assignor"), and RedPrairie Corporation, a Delaware corporation ("Assignee").

WHEREAS, Assignor and Assignee have entered into that certain Asset Purchase Agreement, dated on even date herewith ("Asset Purchase Agreement");

WHEREAS, the execution and delivery of this Assignment is a condition to Licensee's obligation to consummate the Asset Transaction (as that term is defined in the Asset Purchase Agreement);

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Assignor and Assignee hereby agree as follows:

1. Conveyance and Acceptance. Assignor hereby assigns, transfers, and conveys to Assignee all of Assignor's right, title, and interest in and to the trademarks set forth in the attached Schedule A ("Trademarks"), the goodwill associated therewith and symbolized thereby, all registrations and applications for registration thereof, the right to sue, either at law or in equity and the right to recover for any past, present, or future infringements thereof, the right to secure registration of the Trademarks and of this Assignment, and the right to initiate other proceedings before all government and administrative bodies with respect to the Trademarks.

2. Further Action. Assignor agrees to do all acts and take such further action, including the execution and acknowledgment of such additional documents as Assignee may reasonably request, to carry out and fulfill the purposes and intent of this Assignment.

3. Counterparts. This Assignment may be executed in any number of counterparts, each of which shall be deemed an original (including facsimile copies), but all of which together shall constitute one and the same instrument.


