RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT is made as of June 11, 2012 (this "Release") by BANK OF AMERICA, N.A., acting in its capacity as administrative agent and collateral agent for itself and other lenders ("Agent"), to and in favor of SAVANNAH FOODS & INDUSTRIES, INC. ("Pledgor").

S. Patent and Trademark office on June 10, 2011 at Reel 004559, Frame 0603), as the same may have been amended or modified from time to time (the "Trademark Security Agreement"). Without limiting the generality of the foregoing, Agent hereby releases, terminates and extinguishes its lien on and security interest in the trademarks described on Exhibit A to the Trademark Security Agreement, a true and correct copy of which Exhibit A is attached hereto.
