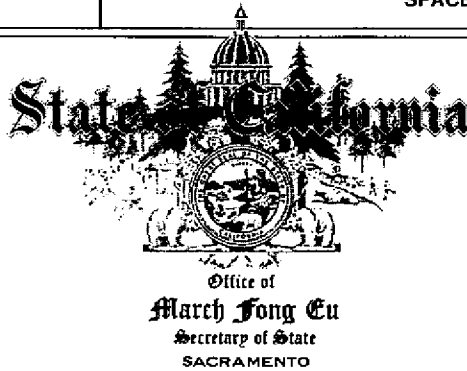

HUNTER INDUSTRIES LIMITED PARTNERSHIP AGREEMENT

This Limited Partnership Agreement is entered into effective December 1, 1991, to memorialize the Agreement made that date among Ann K. Hunter-Welborn, Paul M. Hunter, Richard E. Hunter, and Richard E. Hunter and Janet Hunter, Co-Trustees, and Monica Hunter pursuant to the provisions of the California Revised Limited Partnership Act. The provisions of the partnership agreement are as follows:

ARTICLE 1 - THE PARTNERSHIP

CONVERSION

1.01. The parties hereto are operating a business and own real and personal property in an existing California General Partnership known as Hunter Industries. Such general partnership is hereby converted into a California limited partnership pursuant to this agreement.

NAME

1.02. The Partnership's name is Hunter Industries L.P. The business of the Partnership shall be conducted under that name.

PURPOSE OF PARTNERSHIP

1.03. The Partnership shall engage in the business of manufacturing and distributing irrigation equipment and any activities that are related or incidental to that business. The partnership may engage in any other business agreed upon by the majority in ownership of all partners.


