TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "Release") is made this 24th day of July, 2012 (the "Release Date") by TriplePoint Capital LLC, a Delaware limited liability company (the "Secured Party"), for the benefit of PureWave Networks, Inc., a Delaware corporation (the "Debtor").

WHEREAS, the Debtor has entered into that certain Plain English Growth Capital Loan and Security Agreement with Secured Party, dated as of November 16, 2007 (as at any time prior to the date hereof amended, supplemented or otherwise modified, the "Loan Agreement");

WHEREAS, the Debtor has entered into that certain Plain English Intellectual Property Security Agreement, dated as of April 13, 2010 with Secured Party (as at any time prior to the date hereof amended, supplemented or otherwise modified, the "Security Agreement"), pursuant to which the Debtor granted to the Secured Party security interests and liens in and to all of Debtor's right, title and interest in, to and under the following, whether now existing or hereafter acquired (all of the following items of property will be collectively referred to as the "Intellectual Property Collateral"): (a) all Patents, Patent Licenses, and Patent applications, including specifically those listed in attached Exhibit A together with any reissues, divisions, continuations, renewals, extensions and continuations thereof (the "Patents"), (b) all Trademarks, Trademark Licenses and trademark applications, including specifically those listed in attached Exhibit B together with any renewals thereof (the "Marks") (c) all Copyrights, Copyright Licenses, and applications for Copyrights, (d) the right to sue for past, present and future infringements of the foregoing and all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof, and (e) all Proceeds.

WHEREAS, Secured Party has filed with the United States Patent and Trademark Office (the "USPTO") notices of security interests in the Marks and Patents; and

WHEREAS, the Debtor has paid all outstanding amounts currently owing under the Loan Agreement and the other financing documents executed in connection therewith and has requested that the Secured Party release its security interest in the Intellectual Property Collateral, and the Secured Party desires to release its security interest in the Intellectual Property Collateral.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, Secured Party hereby irrevocably and forever terminates, releases and discharges any and all security interests and any other rights, title and interest it has in, to and under the Intellectual Property Collateral granted to Secured Party by the Debtor under the Loan Agreement and Security Agreement.
2. Recordation of Release. The Secured Party understands and agrees that this Release may be recorded by or for the Debtor with the USPTO.

3. Revocation of Power of Attorney. The appointment of the Secured Party as the Debtor's attorney, as set forth in the Security Agreement, is hereby revoked.

4. Further Actions. Secured Party further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that the Debtor may reasonably require to effect the intent and purpose of this Release, provided that all such documents are to be prepared by counsel to the Debtor and the cost and expense of such documents and actions shall be borne solely by the Debtor.

5. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Loan Agreement and/or the Security Agreement, as applicable.
