TRADEMARK ASSIGNMENT

4. Effective Time. The assignment by Assignor to Assignee of the Trademarks pursuant to this Trademark Assignment shall be effective as of the date hereof.

5. Successors and Assigns. This Trademark Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

6. Counterparts. The parties hereto may execute this Trademark Assignment in one or more counterparts, each of which shall be deemed an original, but all counterparts taken together shall constitute one and the same instrument.

7. Descriptive Headings. The headings used in this Trademark Assignment are for reference purposes only, and shall not in any way affect the meaning or interpretation of this Trademark Assignment.

8. Governing Law. This Trademark Assignment shall be governed by and construed in accordance with the laws of The Commonwealth of Massachusetts, without regard to conflicts of laws principles thereof.

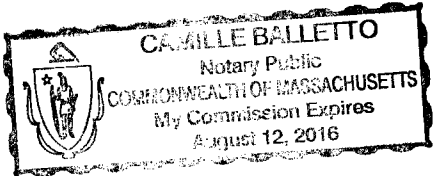

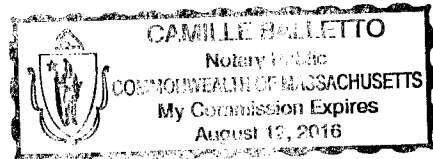
