## NUNC PRO TUNC TRADEMARK ASSIGNMENT

This Nunc Pro Tunc Trademark Assignment is between Pier Five Services, Inc., a Massachusetts corporation located at World Trade Center, 164 Northern Avenue, Boston, Massachusetts 02210 ("Assignor") and FMR LLC, a Delaware limited liability company located at 82 Devonshire Street, Boston, Massachusetts 02109 ("Assignee").

WHEREAS, Assignor was the owner of the marks in the attached SCHEDULE OF TRADEMARKS (hereinafter referred to as the "TRADEMARKS") on the Assignment Date (defined below);

WHEREAS, Assignee acquired said TRADEMARKS together with the goodwill of the business with which said TRADEMARKS are associated, and the issued U.S. registrations for said marks, as of the Assignment Date; and
