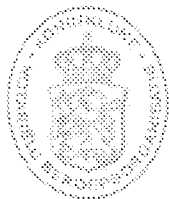

The undersigned:

Inge van Sliedregt, candidate civil law notary, hereinafter referred to as: "civil law notary", as a substitute of Constantinus Jacobus Maria Commissaris, civil law notary, officiating in Rotterdam, the Netherlands,

declares:

1. by notarial deed, executed before me, civil law notary, on 17 July 2012, **Nidera Handelscompagnie B.V.** (the "**Acquiring Company**") and **Nidera Holdings B.V.** (the "**Disappearing Company**") have merged within the meaning of Title 7, Book 2 of the Dutch Civil Code, hereinafter referred to as: **Merger**;
2. pursuant to the Merger, which came into effect on 18 July 2012, the Acquiring Company has acquired all assets and liabilities of the Disappearing Company under a universal title of succession ("algemene titel") according to article 2:309 of the Dutch Civil Code on 18 July 2012, as a result of which the Acquiring Company has obtained from the Disappearing Company the rights and obligations under existing legal relationships;
3. the Disappearing Company ceased to exist and the shares in the share capital of the Disappearing Company have lapsed as a consequence of the Merger on 18 July 2012;
4. as of 1 October 2011, the Acquiring Company will account for the financial data of the Disappearing Company in its own annual accounts;
5. in the notarial deed of the Merger, the articles of association of the Acquiring Company have been amended, pursuant to which the name of the Acquiring Company has been changed into: **Nidera B.V.** as per 18 July 2012.
