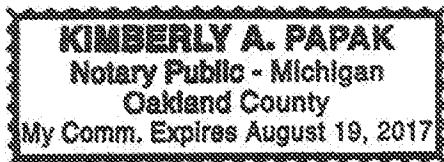
NOW, therefore, for good and valuable consideration, receipt of which is hereby acknowledged, the Assignor does hereby assign unto the Assignee and the Assignee's successors and assigns, *nunc pro tunc* as of JUNE 1, 2012 all rights, title, and interest in and to the mark, together with all registrations and registration applications, both foreign and domestic, that are associated with the mark, together with the goodwill of the business symbolized by the mark, such goodwill including but not limited to the right to market, distribute, and sell products manufactured by the Assignor and previously sold by Assignor in association with the mark, and together with any and all past, present, and future causes of action related to the mark, either in law or equity, including without limitation any claims of infringement or other misappropriation thereof and the right to recover and have damages therefor.
