TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement pertains to the *Kid City* design trademark which had been established by the **Texas Cheerleading Association, Inc.** ("TCA"), a corporation domiciled in the State of Texas with principal place of business located at 303 Spruce Street, Dickinson, Galveston County, Texas 77539. The TCA adopted use of the *Kid City* trademark in conjunction with day care services for children at least as early as January 7, 2006, and perfected its associated trademark rights by being granted Trademark Registration No. 3,204,491 on January 30, 2007.

In consideration of and in exchange for the sum of ten dollars and other good and valuable consideration, on or about February 7, 2007, TCA assigned all its right, title, and interest in the said *Kid City* trademark as recognized by the said Trademark Registration — together with associated good will — to **Kid City Child Care Learning & Sports Center, LLC** ("Kid City CCL&SC"). Kid City CCL&SC had been formed on July 22, 2005 and seamlessly continued rendering high-quality children's day care services at the facility located at 303 Spruce Street, Dickinson, Galveston County, Texas 77539, in accordance with the long-standing tradition engendered since as early as January 7, 2006. TCA ceased doing business on or about January 31, 2008.

This Agreement hereby acknowledges assignment to Kid City CCL&SC by TCA of all right, title and interest in the said *Kid City* design trademark, and Registration No. 3,204,491, together with the good will symbolized by and associated with this trademark; and has been executed at 201 Spruce, Dickinson, Galveston County, Texas, on July 13, 2012.
