Assignor hereby represents, warrants, and covenants to Assignee as follows:

- (a) Assignor to hereby agrees to forever defend the transfer of the intellectual property rights transferred hereunder and title thereto, if and as applicable, unto Assignee, its successors and assigns, against every person whomsoever making any claim thereto, or to any part thereof.
- (b) The representations, warranties, covenants contained in the Asset Purchase Agreement dated as of the date hereof between Assignor and Assignee are incorporated herein by this reference.
- (c) Assignor hereby constitutes and appoints Assignee, its successors, and assigns, the true and lawful attorney and attorneys of Assignor, with full power of substitution, for it and in its name and stead, or otherwise, by or on behalf of and for the benefit of Assignor, its successors and assigns, upon prior notice to Assignor, to do all acts and things, as Assignee, its successors, and assigns, shall deem reasonably necessary or desirable to effectuate the transactions contemplated hereby.
- (d) Assignor agrees, for itself and its successors and assigns, for no additional consideration, to do, execute and deliver, or cause to be done, executed and delivered, all such further acts, transfers, assignments, instruments, and conveyances, for the better assigning, conveying and transferring unto Assignee, its successors and assigns, the intellectual property rights hereby assigned transferred, and conveyed as Assignee, its successors and




