DECLARATION IN SUPPORT OF REQUEST FOR CORRECTION OF RECORDS

Pursuant to 37 C.F.R. §2.20, the undersigned declares as follows:

1. I am a partner with the law firm of Pattishall, McAuliffe, Newbury, Hilliard & Geraldson LLP in Chicago, Illinois. All statements made herein are made on the basis of personal knowledge and review of certain documents and materials referred to herein.

2. On January 28, 1999, an assignment was recorded by Colette A. Durst-Barkey of this firm to reflect the transfer of property from Knight Ridder, Inc. to Classified Ventures, L.L.C. for the trademarks HOMEHUNTER, Reg. No. 2043583 and HOMEHUNTER NET, Reg. No. 2057546. That assignment incorrectly reflected the registration number for HOMEHUNTER NET as Reg. No. 2057541. The correct registration number should reflect Reg. No. 2057546. I enclose copies of the assignment and cover sheet with this declaration.

3. Reg. No. 2057541 is for the mark SNAP-TITE and was originally owned by Irrigation Supply Company, Incorporated. On September 25, 1996, a name change was recorded to reflect the change of name to ISCO Industries, Inc. On June 5, 2012, an assignment was recorded from ISCO Industries, Inc. to ISCO Industries LLC. Knight Ridder, Inc. never owned this trademark registration and therefore could not transfer the trademark rights for the SNAP-TITE mark to Classified Venture, L.L.C.

4. I have reviewed the documents recorded with the Assignment Branch of the United States Patent and Trademark Office (USPTO) at Reel 1846/ Frames 0282 - 0283. I confirm that the assignment recorded against U.S. trademark registration 2057541 was in error and the correct registration number should have listed U.S. trademark registration no. 2057546 for the HOMEHUNTER NET mark.

The undersigned being warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. §1001, and that such willful false statements and the like may jeopardize the validity of the application or document or any registration resulting therefrom, declares that all statements made of his/her own knowledge are true; and all statements made on information and belief are believed to be true.

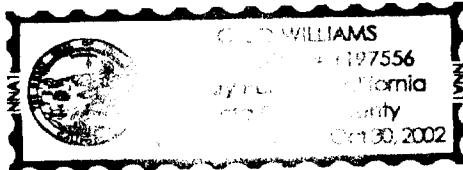
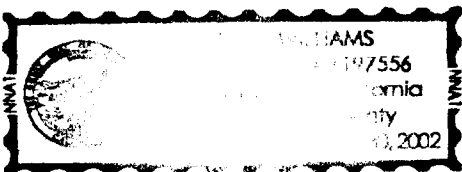
