## **RELEASE OF TRADEMARK SECURITY INTEREST**

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made effective as of August 1, 2012 by JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, (the "Administrative Agent") to INERGY PROPANE, LLC, successor-in-interest to Inergy Gas, LLC ("Inergy Propane"), as follows:

WHEREAS, on December 17, 2004, Inergy, L.P. (the "Borrower"), Inergy Propane, Inergy Gas, LLC, certain other Subsidiaries of the Borrower (collectively the "2004 Grantors") and the Administrative Agent entered into a Pledge and Security Agreement (the "2004 Security Agreement") and a Trademark Security Agreement (the "2004 Trademark Agreement");

WHEREAS, pursuant to said 2004 Security Agreement and 2004 Trademark Agreement, the 2004 Grantors granted to the Administrative Agent on behalf of the Holders of the Secured Obligations, among other collateral, a security interest in, as and by way of a first mortgage and security interest having priority over all other security interests (except any Permitted Liens), with power to sale to the extent permitted by applicable law, all of such 2004 Grantor's now owned or existing and hereafter acquired or arising Trademarks, including goodwill, and Licenses in, to and under the United States Trademarks listed on the attached Schedule A (the "2004 Marks");

WHEREAS, said 2004 Trademark Agreement was recorded in the United States Patent & Trademark Office on December 28, 2004 at reel/frame 002998/0181 with respect to Inergy Propane trademarks and at reel/frame 002998/231 with respect to Inergy Gas, LLC trademarks;

WHEREAS, on November 24, 2009, the Borrower, Inergy Propane, Stellar Propane Service, LLC, US Salt, LLC (collectively the "2009 Grantors") and the Administrative Agent entered into a Pledge and Security Agreement (the "2009 Security Agreement") and a Trademark Security Agreement (the "2009 Trademark Agreement");

WHEREAS, pursuant to said 2009 Security Agreement and 2009 Trademark Agreement, Inergy Propane granted to the Administrative Agent on behalf of the Holders of the Secured Obligations, among other collateral, a security interest in, as and by way of a first mortgage and security interest having priority over all other security interests (except any Permitted Liens), with power to sale to the extent permitted by applicable law, all of Inergy Propane's now owned or existing and hereafter acquired or arising Trademarks, including goodwill, and Licenses in, to and under the United States Trademarks listed on the attached Schedule B (the "2009 Marks");


WHEREAS, said 2009 Trademark Agreement was recorded in the United States Patent & Trademark Office on November 25, 2009 at reel/frame 004103/0499 with respect to Inergy Propane trademarks; and

WHEREAS, the Administrative Agent wishes to release its security interest in the 2004 and 2009 Marks listed on Schedules A and B.

NOW THEREFORE, as Inergy Propane has satisfied its obligations under said Security Agreements and Trademark Agreements listed above, the Administrative Agent hereby terminates, releases and discharges any security interest in and lien upon the 2004 and 2009 Marks listed on Schedules A and B, and assigns, transfers, and conveys to Inergy Propane any and all right, title or interest in, or to, the 2004 and 2009 Marks listed on Schedules A and B that the Administrative Agent may hold.
