RESTATED
CERTIFICATE OF INCORPORATION
OF
TAXITRONIC, INC.

Pursuant to Section 807 of the
New York Business Corporation Law

The undersigned President of Taxitronic, Inc. (the "Corporation") does hereby certify:

1. The name of the Corporation is Taxitronic, Inc.
2. The Certificate of Incorporation of the Corporation was filed by the New York Department of State on July 24, 1997.
3. The Certificate of Incorporation is hereby amended to (i) change the name of the Corporation; (ii) change the Corporation's address for service of process; and (iii) increase the number of shares of capital stock.
4. The Certificate of Incorporation so adopted reads in its entirety as set as follows:

**CERTIFICATE OF INCORPORATION OF
VERIFONE TRANSPORTATION SYSTEMS, INC.**

ARTICLE I

The name of the Corporation is VeriFone Transportation Systems, Inc.

ARTICLE II

The office of the Corporation within the State of New York shall be located in the County of New York.

ARTICLE III

The Secretary of State is designated as agent of the Corporation upon whom process against it may be served. The post office address to which the Secretary of State shall mail a copy of any process against the Corporation served upon him is:

ARTICLE IV

The nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the New York Business Corporation Law.

ARTICLE V

The aggregate number of shares which the Corporation shall have the authority to issue is One Thousand (1,000), all of which shall be designated as Common Stock without par value.

ARTICLE VI

The Corporation is to have perpetual existence.

ARTICLE VII

Except as otherwise provided in this Certificate of Incorporation, the Board of Directors of the Corporation may make, repeal, alter, amend or rescind any or all of the Bylaws of the Corporation.

ARTICLE VIII

The number of directors which constitute the whole Board of Directors of the Corporation shall be not less than five and not more than seven, with the exact number to be fixed from time to time by resolution of the Board of Directors of the Corporation.

ARTICLE IX

The election of directors by the shareholders shall be subject to a voting agreement amongst the shareholders of the Corporation to elect their respective nominees to the Board of Directors of the Corporation. New shareholders, upon so becoming, shall be subject to such voting agreement.

ARTICLE X

Meetings of shareholders of the Corporation may be held within or without the State of New York, as the Bylaws may provide. The books of the Corporation may be kept (subject to any provision contained in the statutes) outside the State of New York at such place or places as may be designated from time to time by the Board of Directors of the Corporation or in the Bylaws of the Corporation.

ARTICLE XI

The Corporation may amend, alter, change or repeal any provision contained in this Certificate of Incorporation, in the manner now or hereafter prescribed by statute. All rights conferred on shareholders of the Corporation herein are granted subject to this reservation.

ARTICLE XII

To the fullest extent permitted under New York law, as the same may be amended from time to time, a director of the Corporation shall not be personally liable to the Corporation or its shareholders for monetary damages for breach of fiduciary duty as a director. If the New York Business Corporation Law is hereafter amended to authorize, with or without the approval of a corporation's shareholders, further reductions in the liability of the corporation's directors for breach of fiduciary duty, then a director of the Corporation shall not be liable for any such breach to the fullest extent permitted by the New York Business Corporation Law as so amended.

Any repeal or modification of the foregoing provisions of this Article XII, by amendment of this Article XII or by operation of law, shall not adversely affect any right or protection of a director of the Corporation with respect to any acts or omissions of such director occurring prior to such repeal or modification.

ARTICLE XIII

To the fullest extent permitted by applicable law, the Corporation is authorized to provide indemnification of (and advancement of expenses to) directors, officers, employees and other agents of the Corporation (and any other persons to which New York law permits the Corporation to provide indemnification), through Bylaw provisions, agreements with any such director, officer, employee or other agent or other person, vote of shareholders or disinterested directors, or otherwise, in excess of the indemnification and advancement otherwise permitted by Section 722 of the New York Business Corporation Law, subject only to limits created by applicable New York law (statutory or nonstatutory), with respect to actions for breach of duty to a corporation, its shareholders and others.

Any repeal or modification of any of the foregoing provisions of this Article XIII, by amendment of this Article XIII or by operation of law, shall not adversely affect any right or protection of a director, officer, employee or other agent of the Corporation or other person existing at the time of, or increase the liability of any director of the Corporation with respect to any acts or omissions of such director, officer or agent occurring prior to such repeal or modification.

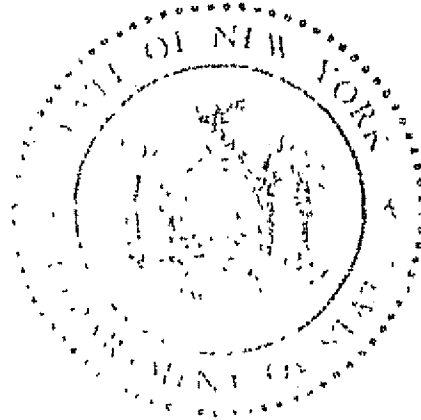
