DECLARATION OF SCOTT Q. VIDAS

1. My name is Scott Q. Vidas. I am counsel for Fabcon Companies, LLC., (FABCON) the owner of U.S. Trademark Registration Number 757,583 and the mark SPAN DECK.
2. On April 28, 1986 the assignment of the mark and registration to FABCON was recorded at Reel/Frame: 0523/0823. All rights to the mark were passed from the prior owner Span-Deck, Inc. to FABCON.
3. On September 11, 2003, I submitted a combined Declaration of Use in Commerce and Application for Renewal under Sections 8 and 9 which was accepted.
4. On February 10, 2004, Spandeck, Inc. recorded a security interest at reel/frame 2790/0639, to Capital Business Credit, Inc., a Division of Capital factors, Inc. against this registration.
5. Since all rights that Spandeck, Inc. had to the mark and registration were passed to FABCON, Spandeck, Inc. had no rights to convey and any attempt to lodge a security interest against this registration was in error and recorded document Reel/Frame: 2790/0639 should not be considered against this registration.
6. The required recordation filing fee and complete cover sheet for recordation are also being submitted.

I further declare that all statements made herein of my knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 at the United States Code and that such willful false statements may jeopardize the validity of the application or any patent issued thereon.
