RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, The Del-Nat Tire Corporation, a Nevada corporation (“Debtor”) is a party to that certain Loan and Security Agreement (the “Loan Agreement”) dated August 13, 2007 by and among Debtor, Del-Nat Capital Asset Company, LLC, a Tennessee limited liability company (“Capital”, and together with Debtor, each individually a “Borrower” and collectively, “Borrowers”), and Del-Nat Import Export Company, a Nevada corporation (“Guarantor”), Wells Fargo Bank, National Association, successor by merger to Wachovia Bank, National Association, in its capacity as agent (“Secured Party”);

WHEREAS, Debtor granted a security interest in and lien upon certain trademarks, trademark applications and the other Collateral (as defined in the Trademark Security Agreement) to Secured Party as set forth in that certain Trademark Collateral Assignment and Security Agreement, dated August 13, 2007, by Debtor in favor of Secured Party (the “Trademark Security Agreement”);

WHEREAS, an executed copy of the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on September 18, 2007 at Reel 003623, Frame 0239; and

WHEREAS, in connection with the satisfaction of the Obligations (as defined in the Loan Agreement) and the termination of the Trademark Security Agreement pursuant to a Termination Agreement dated as of the date hereof by and among Borrowers, Guarantor and Secured Party, Debtor has requested that Secured Party release and reassign its interest in the trademarks and trademark applications more fully identified in Schedule A annexed hereto and made a part hereof, and any other Collateral (as defined in the Trademark Security Agreement), together with the goodwill of the business symbolized thereby;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. releases and reassigns to Debtor any and all liens, security interests, right, title and interest of Secured Party in the trademarks and trademark applications more fully identified in Schedule A annexed hereto, and any other Collateral (as defined in the Trademark Security Agreement), together with the goodwill of the business symbolized thereby;
2. agrees that any power of attorney or similar rights granted by Debtor to Secured Party pursuant to or in connection with the Trademark Security Agreement is terminated, including, without limitation, the Special Power of Attorney, dated August 13, 2007, granted to Secured Party by Debtor; and
3. authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given and any other filings necessary to evidence the release and termination of Secured Party’s rights under the Trademark Security Agreement.

The validity, interpretation and enforcement of this Release of Security Interest in Trademarks shall be governed by the internal laws of the State of North Carolina but excluding any principles of conflicts of law or other rule of law that would cause the application of the law of any jurisdiction other than the laws of the State of North Carolina.
