CONFIRMATORY ASSIGNMENT



NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN:

Be it known that, in consideration of the payment by ASSIGNEE to ASSIGNOR of the sum of TEN DOLLARS (\$10.00) and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, effective as of December 31, 2009, ASSIGNOR conveyed, assigned, transferred and delivered unto ASSIGNEE its entire worldwide right, title and interest in and to the Intellectual Property, including, without limitation, all renewals therefore, all proceeds therefrom (including, but not limited to, all license royalties and proceeds of infringement suits), and the right to sue for past, present and future infringements of the Intellectual Property.
