CONFIRMATORY TRADEMARK ASSIGNMENT



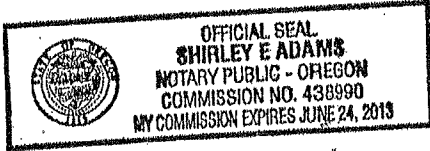
