

CERTIFICATE OF AMENDMENT OF CERTIFICATE OF ORGANIZATION

Pursuant to the provisions of the Massachusetts Limited Liability Company Act, Massachusetts General Laws, ch. 156C (the "Act"), the undersigned hereby certifies as follows.


