**ARTICLES OF MERGER
OF MAHARISHI AYUR-VED PRODUCTS INTERNATIONAL, INC. INTO
MAHARISHI AYUR-VED PRODUCTS INTERNATIONAL CORPORATION**

1. The names of the parties to the merger are Maharishi Ayur-Ved Products International Corporation, an Iowa corporation (the "Surviving Corporation") and Maharishi Ayur-Ved Products International, Inc., a Colorado corporation ("Colorado Corp."). The Surviving Corporation shall be the surviving corporation in the merger.

2. The effective date of the merger is October 17, 2010.

3. The Articles of Incorporation of the Surviving Corporation were transmitted to the Secretary of State of Iowa for filing on October 14, 2010, and the Surviving Corporation came into existence on October 17, 2010.

4. The plan of merger was duly approved by the sole shareholder of the Surviving Corporation in a manner required by the business corporation law of the state of Iowa.

5. The plan of merger and the performance of the terms of the merger have been duly authorized by all action required under the laws of Colorado, under which Colorado Corp. is organized, and under the articles of incorporation of Colorado Corp.
