TRADEMARK COLLATERAL AGREEMENT

This 30th day of July, 2012, HOMEWERKS WORLDWIDE, LLC, a Delaware limited liability company ("*Company*") with its principal place of business and mailing address at 500 Bond Street, Lincolnshire, Illinois 60069 in consideration of ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, assigns to BMO HARRIS BANK N.A., a national banking association, with its mailing address at 111 West Monroe, Chicago, Illinois 60603, and its successors and assigns ("*Lender*"), and grants to Lender a continuing security interest in the following property:

(i) Each trademark, trademark registration, and trademark registration application listed on Schedule A hereto (each, a "*Trademark*"), and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(ii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any Trademark or by reason of injury to the goodwill associated with any such Trademark, in each case together with the right to sue for and collect said damages;

to secure the payment and performance of all Obligations of Company and each of its Subsidiaries which may be party to and as set out in that certain Credit and Security Agreement bearing even date herewith between Company and Lender, as the same may be amended, modified, or restated from time to time (the "*Credit and Security Agreement*").


Notwithstanding anything herein to the contrary, this Trademark Collateral Agreement shall not operate as a sale, transfer, conveyance or other assignment to Lender of any applications by Company for a trademark based on an intent to use the same if and so long as such application is pending without a Statement of Use having been filed and accepted (such pending applications which are based on intent to use being hereinafter referred to collectively as "*Intent-to-Use Applications*"), but rather, if and so long as Company's Intent-to-Use Application is pending without a Statement of Use having been filed and accepted, then this Trademark Collateral Agreement shall operate only to create a security interest for collateral purposes in favor of Lender on such Intent-to-Use Application as collateral security for the Obligations. When a Statement of Use is filed and accepted by the Trademark Office, then that application shall cease to be partly exempted from this Agreement.

Company does hereby further acknowledge and affirm that the rights and remedies of Lender with respect to the collateral assignment and security interest in the Trademarks, made and granted hereby are more fully set forth in the Credit and Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein.


