ASSIGNMENT OF TRADEMARK AND REGISTRATION

PAWS OFF®

This Assignment of the Trademark PAWS OFF (the "Assignment") is made and entered on AUG. 10th 2012, by and between **Triarco Industries, Inc.**, a corporation organized and existing under the laws of the State of Delaware, having a principal place of business at 400 Hamburg Turnpike, Wayne, New Jersey 07470 ("Triarco"), and **Invested in Health Holdings, LLC**, a Limited Liability Company organized and existing under the laws of the State of New Jersey, having a place of business at 400 Hamburg Turnpike, Wayne, New Jersey 07470 ("IHH") (collectively referred to as the "Parties," and individually, a "Party.")

Whereas, Triarco is the record owner of the mark PAWS OFF (words only) (hereinafter, the "Mark") and the Registration of the Mark on the Principal Register of the United States Patent and Trademark Office (the "USPTO"), Registration No. 3,758,824, with a filing date of November 12, 2008, and a registration date of March 9, 2010 (the "Registration"); and

Whereas, Triarco desires to sell, convey, transfer, assign and deliver to IHH, and IHH desires to acquire from Triarco, all of Triarco's interest in and to the Mark and the Registration upon the terms and subject to the conditions set forth herein.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. ASSIGNMENT:

(a) Triarco hereby agrees to sell, convey, transfer, assign and deliver to IHH, its successors and assigns, and IHH hereby agrees to acquire from Triarco, upon the terms and subject to the conditions set for in this Assignment, all of Triarco's right, title and interest, whether statutory or at common law, in and to the Mark and the Registration, together with the goodwill of the business symbolized by the Mark throughout the world, together with all causes of action for any and all previously occurring infringements of the rights being assigned and the right to receive and retain the proceeds relating to those infringements.

(b) Triarco agrees to execute further papers and to do such other acts as may be necessary and proper to vest full title in and to the Mark in IHH.

2. TRIARCO'S REPRESENTATIONS:

(a) Triarco represents and warrants that Triarco is the sole owner of the Mark and the Registration and that Triarco has the power and authority to enter into this Assignment.

(b) Triarco further represents and warrants that the rights transferred in this Assignment are free of lien, encumbrance or adverse claim of any nature or kind whatsoever.

3. GOVERNING LAW:

This Assignment shall be governed by and construed in accordance with the laws of the State of New Jersey.

4. BINDING EFFECT:

The covenants and conditions contained in this Assignment shall apply to and bind the Parties and their heirs, legal representatives, successors and permitted assigns. This Assignment may be executed in several counterparts, each of which shall be deemed to be an original, but all of which together will constitute one and the same instrument.
