RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of August 6, 2012 ("Effective Date") by WELLS FARGO CAPITAL FINANCE, LLC, a Delaware limited liability company, in its capacity as agent for the Lender Group and the Bank Product Providers (in such capacity, "Agent"), in favor of CONSONA CORPORATION, CONSONA ERP, INC., CAPRI CORP., CIMNET SYSTEMS, INC., CIMNET SYSTEMS SERVICES, LLC., CSI-1, LLC, AND CSI-2, INC. and CONSONA CRM, INC. (collectively, jointly and severally, "Grantors" and each individually "Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantors and Agent dated May 28, 2010 (the "Trademark Security Agreement"), Grantors granted to Agent a continuing security interest in and to all of Grantors' right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Grantors (collectively, the "Trademark Collateral"), including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto, together with the goodwill associated therewith;

WHEREAS, Grantors and Agent entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Security Agreement by and between Grantors and Agent dated May 28, 2010 (the "Security Agreement");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on January 20, 2011, at Reel 4457, Frame 0754; and

WHEREAS, Grantors have paid all of their outstanding indebtedness to Agent.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates the Trademark Security Agreement and the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademark Collateral.

Agent represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademark Collateral; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register any trademark, or any trade name or assumed name, other than those Trademark Collateral set forth on Schedule A (attached hereto), in any jurisdiction throughout the world, other than such filings made in the United States Patent and Trademark Office.

Agent shall at Grantors' expense take all further actions, and provide to Grantors, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Release.
