## RELEASE OF INTELLECTUAL PROPERTY COLLATERAL LIEN

This RELEASE OF INTELLECTUAL PROPERTY COLLATERAL LIEN (this "Release"), dated as of August 3, 2012, is made by ATALAYA ADMINISTRATIVE LLC, (in its individual capacity, "Atalaya Administrative"), in its capacity as successor to CapitalSource Finance LLC as administrative, payment, and collateral agent for the Lenders from time to time parties to that certain Credit Agreement described below (Atalaya Administrative, in such capacity, hereinafter is referred to as the "Secured Party").

### RECITALS:

A. SiTV, Inc., a Delaware corporation ("Borrower"), SiTV Media, Inc., a Delaware corporation ("Holdings"), JAAM Productions, LLC, a Delaware limited liability company ("JAAM"), SCN Distribution, LLC, a Delaware limited liability company ("SCN"), and Latino Events LLC, a Delaware limited liability company ("Latino Events") (Borrower, Holdings, JAAM, SCN, and Latino Events sometimes hereinafter are referred to collectively as the "Credit Parties"), the financial institutions from time to time parties thereto, as Lenders thereunder, and CapitalSource Finance LLC (in its individual capacity, "CapitalSource"), as administrative, payment, and collateral agent for the Lenders thereunder (CapitalSource, in such capacity, hereinafter is referred to as the "Original Secured Party") entered into that certain Credit Agreement dated as of January 3, 2007 (such Credit Agreement, as the same has been amended, modified, supplemented, extended, renewed, restated, and/or replaced from time to time, hereinafter is referred to as the "Credit Agreement").

B. The Credit Parties issued an Acknowledgement of Intellectual Property Collateral Lien dated as of January 3, 2007 and recorded in the U.S. Patent and Trademark Office Assignment Services Branch on January 10, 2007, at Reel 003458, Frame 0732 (the "Recorded Lien") with respect to the registered trademarks identified on Schedule I attached hereto (the "Registered Trademarks") in favor of the Original Secured Party pursuant to which the Credit Parties granted a security interest in the Registered Trademarks to the Original Secured Party.

C. The Credit Parties, the Original Secured Party, the Lenders, and the Secured Party entered into that certain Resignation of Agent and Appointment of Agent Agreement dated as of April 23, 2010 (the "Agent Resignation and Appointment") pursuant to which (i) the Original Secured Party resigned as agent for the Lenders under the Credit Agreement, (ii) the Lenders appointed the Secured Party as their agent under the Credit Agreement, and (iii) the Original Secured Party agreed to assign all of its right, title, and interest in and to the Recorded Lien and the Registered Trademarks to the Secured Party.

D. The Original Secured Party executed and delivered to the Secured Party that certain Assignment of Intellectual Property Collateral Lien dated as of May 20, 2010 and recorded on May 24, 2010 at Reel 004211, Frame 0683 the "Recorded Assignment of Lien") pursuant to which the Original Secured Party assigned all of its right, title, and interest in and to the Recorded Lien and the Registered Trademarks to the Secured Party.

E. The Credit Parties have refinanced their debt owing to the Lenders in full. Secured Party is executing and delivering this Release in order to evidence the release all of Secured Party's right, title, and interest in and to the Registered Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, Secured Party does hereby (i) release the Recorded Lien, the Recorded Assignment of Lien, and all of its right, title, and interest in and to the Registered Trademarks acquired by Secured Party by virtue of the Recorded Lien and/or the Recorded Assignment, and (ii) grant, assign, sell, and convey unto the registered holder of the Registered Trademarks, without recourse, representation, or warranty, all right, title, and interest in and to the Registered Trademarks which Secured Party now has or heretofore may have acquired by virtue of the Recorded Lien and/or the Recorded Assignment of Lien.



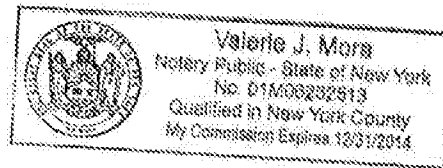
